## Children find safety with Family in Mexico

Jose and Enrique were removed from their home by Virginia Child Protective Services due to their father’s alleged sexual abuse. Their mother, who had been recently deported to Mexico, wanted her children to live with her in Mexico. Based on the detailed information that the International Social Service social worker obtained in Mexico, the boys were happily reunited with their mother in Mexico.

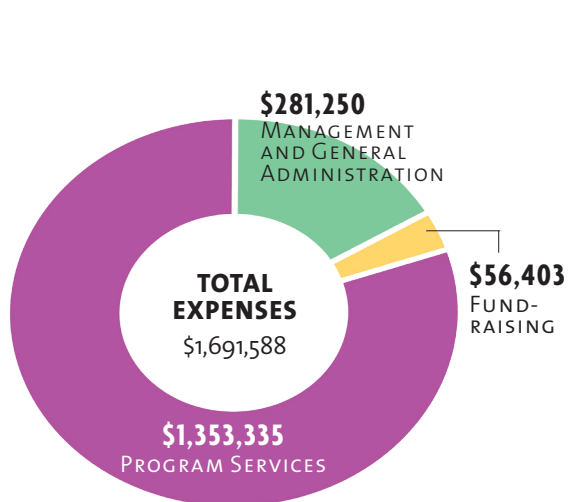
## Teenager only wants to return “home” to the Dominican Republic

Edgar’s mother left the Dominican Republic (DR) to work in New York when Edgar was 1 year old; he stayed in the DR and was raised by a close family friend. His mother secured immigration paperwork to bring Edgar to New York at age 13. When in NY, Edgar was allegedly abused by his mother’s boyfriend and began associating with a local gang. International Social Service worked with Social Services in the DR to obtain the information needed by the court to decide if Edgar should remain in NY or return to the DR.

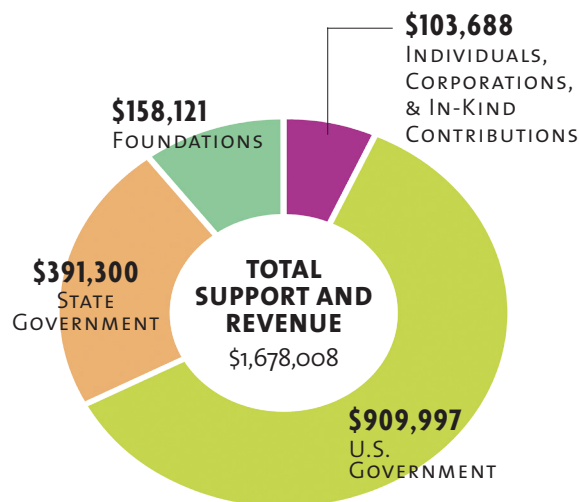

International Social Service-USA is the U.S. member of a **global child protection and social service network**.

We mobilize a **domestic and international network** of legal and social work professionals to efficiently connect **vulnerable children, adults and families** separated by international borders to the services and support they need.

In **2015**, International Social Service-USA supported, protected and reunited more than **2799** vulnerable individuals from all **50 U.S. states** and one U.S. territory, and in more than **80 countries** around the world.

## Child Protection Conference

**Over 280 experts from 66 countries** attended, including child protection authorities, judges, social workers, mediators, lawyers, psychologists, and international organizations. The conference promoted and strengthened the effective implementation of the Hague Child Protection Convention of 1996 and facilitated dialogue on the socio-legal dimensions of international child-protection. **The ISS network was highly visible, with more than 22 countries and 60 ISS staff, board and volunteers** facilitating, presenting, volunteering and attending the conference.

**583** of the total vulnerable individuals who received services were **children**, with an average age of **9**. **61** of these **children** were abandoned in other countries due to abuse or neglect and were safely returned to the U.S. **100** of these children **came back** to the **U.S. with destitute families** who were sometimes escaping domestic violence.

## An Expanded Network: Larger Impact Worldwide



**66 delegates from 33 countries** made a historic decision at the **2016 International Council Meeting in Melbourne, Australia**. By resolving to expand membership, International Social Service **will create more opportunities for organizations to join our Network and adhere to our working principles**, as well as actively participate in the creation of policies and decisions. International Social Service is now better equipped to serve more and more children and families on the move.

# FOUNDATIONS

## Global Realities Demand Strategic Investment in the Future

**More people are displaced today than during any other period in history.** Our staff and board gathered together at the Grand Hotel on Mackinac Island, Michigan to strategically assess **how to further increase our breadth and depth of services.** International Social Service - USA, in collaboration with other national and global partners, is committed to address these critical issues by: **(1)** Expanding our current services to benefit more vulnerable people; **(2)** Assuming our role as a unique, national expert that is part of a global network; and **(3)** Increasing our revenue over the next 3-5 years to enable us to assist more people in need.



Social workers verified the well-being of **100** children by ensuring that the **child's home environment was safe.** **30** children thought to be in **danger of abuse or neglect** were visited in their homes by police and social workers. **451** **vulnerable adults** were safely returned to the U.S. because they were destitute or had severe medical conditions.

## Building the Network in Central America



**To help build regional capacity in the Northern Triangle region** and work to provide safe repatriation, reunification, and reintegration strategies for migrating children and families, International Social Service hosted a conference in Guatemala titled **"Coordinated Cross-Border Social Services for Children and Families Migrating in the Northern Triangle, Mexico**

**and the U.S."** Twenty six participants from five countries representing government, civil society and academia participated and developed a list of commitments towards establishing a coordinated network for cross-border services for migrating children. Action steps included maintaining ongoing, cross-border contact with conference participants and the extended network of stakeholders to deliver safe repatriation, reunification and reintegration services to migrating children and families.

## National Blueprint Champion for Excellence Award



International Social Service was awarded the 2015 CWLA National Blueprint Champion for Excellence Award in the category of Agency Innovator **for demonstrating innovation and excellence in the delivery of programs and services** to advance improved outcomes for children and youth using the principles of the National Blueprint.
